1.1 Length

The anticipated length of the paper is 3–5 pages maximum length, including the abstract, figures, and references.

1.2 Language

Your manuscript must be prepared in British English using Oxford spelling. Please visit https://en.wikipedia.org/wiki/Oxford_spelling for further information. The use of Oxford commas is encouraged. Further, we ask you to make use of en dashes (written as --) to separate logical sections of your sentences in cases when commas or parentheses are no suitable options. Note that en dashes shall be surrounded by whitespace.

1.3 Sections and Subsections

Headings must be capitalized. Further, the hierarchical structure of your manuscript should not exceed two levels, i.e., the maximum depth you should use is subsections. If you need additional structuring, please use titled paragraphs as outlined below:

1.4 Abbreviations

Please use abbreviations wherever appropriate, in particular, for ‘that is’ and ‘for example’. We offer pre-defined shortcuts for ‘that is’ (`\ie`) and for ‘for example’ (`\eg`). In case you might want to begin a sentence with one of those (or comparable) words, please refrain from using abbreviations.

1.5 Foot and Endnotes

You can add endnotes by using the `\endnote` command¹. Footnotes are not permitted and will be rendered as endnotes.

1.6 Mathematical Symbols

Mathematical symbols can be written in inline mode, like $x_i = 3$, or as a separated one-line equation:

$$\alpha = \sum_i x_i^2.$$

Please embed your formula in an equation environment in case you want to enumerate and cross-reference your equations:

$$\alpha = \sum_i x_i^2. \tag{1}$$

2 Figures

All artwork must be centred (using the `\centering` command), clean and legible. Do not use hand-drawn artwork. Numbering and caption shall always appear after each figure.

Use the `\ref` command to cross-reference figures in your text (and also tables, see below). Again, similar to citations, please insert a tilde character (`~`) in front of your reference. For example, `Figure~\ref{fig:sample}` would be appropriate to reference Figure 1 in this document.

3 Tables

All tables must be centred (using the `\centering` command). Please use the `booktabs` package, which is preloaded already when using our template – have a look at the example below to understand the commands. Do not use hand-drawn tables. Numbering and caption shall always appear ahead of the respective table.

Protected space can be inserted through a tilde (`~`) in front of citation commands:

`... text~\citep{westerholt2018a}` results in ...text (Westerholt et al., 2018)

This will prevent the typesetting of dangling citations leading new lines of text. You do not have to insert a tilde if you want to start a sentence with a citation:

`\Citet{mocnik2022b}` argues that ... results in Mocnik (2022) argues that ...
